








Figure 1: Distribution of Land Assets of Kırklareli

Total land size of Kırklareli consist 10% first class, 33% second class, 20% third class, 6% forth class, 20% sixth class and 11% seventh class soil.

According to Kırklareli Food, Agriculture and Livestock Directorate; land in Kırklareli is divided into four. 40,39% cultivated area, 39,50% forests and heath, 5,42% pastures and 14,69% non-agricultural land.

The most important products in the province are wheat, sunflower and rice. According to TSI; Kırklareli supplies 2,07% of wheat, 9,6% of sunflower, 2,59% of rice production of Turkey.



#### **Field Crops**

**Cereals:** Rye, oats (grain), corn (grain), rice, birdseed, sorghum (grain), triticale (grain), wheat (other), barley (for beer production), barley (other).

**Oilseeds:** Sunflower, canola, safflower, sesame seeds.

Forage Crops: Alfalfa (dry grass), alfalfa (seed), sainfoin (green grass), sainfoin (dry grass), corn (yield), vetch (green grass), vetch (dry grass), corn (silage).

**Industrial crops:** Sugar beet, tobacco, thyme.



#### Vegetable Production

Most produced vegetables are watermelon, tomato, onion (dry) and pumpkin, respectively. Since the current production amount is less than the potential production amount, there are government incentives and supports for investments on this area in order to increase amounts.



## Greenhouse Production

In recent years, there is an increase in greenhouses in Kırklareli. Production is carried out in plastic greenhouses and low tunnels. There aren't any glass greenhouses and high tunnels. The most important products are tomato, cucumber and lettuce. Since the current production amount is less than the potential production amount, there are government incentives and supports for investments on this area in order to improve cultivation.



#### **Fruit Production**

Seeded grape is produced much and it takes the first place in fruit production in Kırklareli. Grape for wine production, walnut and cherry follow the ranking. Since the current production amount is less than the potential production amount, there are government incentives and supports for investments on this area in order to improve cultivation. - LIVESTOCK -




Figure 3: Contribution of Kırklareli to the Region in terms of Production of Milk, Egg and Honey Source: Kırklareli Current Situation Report, Trakya Development Agency, 2014.




## Beekeeping

According to 81 Provinces Status Report of Ministry of Science, Industry and Technology; Kırklareli takes place between provinces which have developing industries with a ratio of 0,4%. When you have a look at the sectoral distribution of enterprises that have industry registration, "Food, Beverages and Tobacco Industry" has the highest share with its ratio of 32,78%. With a rate of 18,06% "Stone, Soil, Mining Industry" and with 15.38% "Textiles, Clothing and Leather Industry" follow the ranking, respectively.

Figure 6: Exports and Imports Data by Economic Activity (in thousands of USD)



#### Sea and Nature Tourism

Natural beauties such as İğneada, Kıyıköy Coasts, Kasatura Gulf and Demirköy are famous touristic destinations of Kırklareli. İğneada National Park, Kavaklımeşe Wood, Mert Lake, Erikli Lake, Bath Lake and Saka Lake are also prominent natural heritages.

## Ancient Cities and Historical Places

The ancient cities and historical places in the province are; Vize Ancient Theatre, Aşağı Pınar and Kanlıgeçit Mound, Small Hagia Sophia, Pınarhisar Castle, and Polos Castle.

## Ottoman-Era Artifacts

Lüleburgaz Sokullu Mehmet Pasha Islamic Social Complex, Kırklareli Hızırbey Islamic Social Complex, Babaeski Cedid Ali Pasha Mosque, Vize Süleyman Pasha Mosque, Demirköy Iron Foundry, Gazi Süleyman Pasha Mosque are the most significant artifacts remaining from Ottoman-Era.

## Gastronomic Tourism

There are lots of products in the province which have gastronomic value. Milk and dairy products, meat and meat products, wine and Ottoman cuisine are some of them. Kırklareli and Ahmetbey meatballs, turbot of Kırklareli, milky chicken of Büyük Mandıra, feta cheese of Kırklareli can be regarded as the specific examples.

## Tourism Assets Carrying Brand Value


Strandja Mountains:

Strandja Mountains are identified as one of the five most important areas in Central and Eastern Europe at the international level in order to protect European Natural Heritage. In the region there are two protected areas including Kasatura Gulf Nature Protection Area and İğneada Longoz Forests National Park. Dupnisa Cave which is worth to see with its untouched stalactites, stalagmites is located on this region. Dupnisa has a 3 km long gallery with a river inside. The region is also suitable for hunting tourism as well as cave tourism



## İğneada:

İğneada which is next to the blacksea coasts of Kırklareli is a tourism attraction center. Many tours are organized from İstanbul to İğneada thanks to its clean water and untouched nature.

Figure 8: Installed Electrical Power of Turkey (66,134 MW)





Figure 9: Installed **Electrical Power of** Kırklareli (2815 MW)

#### WIND

In studies conducted by Renewable Energy General Directorate it is noted that there are areas in the eastern side of the province suitable for wind power plants. According to the values determined by Renewable Energy General Directorate the wind speed in Kırklareli is at a level of between 5,5 and 7 m/s. Hence it is considered that there is a significant wind potential in the province. There is an installed wind power capacity of 262 MW in Kırklareli.





Figure 10: Map of Potential Wind Energy

Turkey has a high potential for solar energy due to its geographic location. The average annual sunshine duration is 2,640 hours (7.2 hours/day), the average total radiation intensity is 1,311 kWh/m<sup>2</sup>-year (3.6 kWh / m<sup>2</sup>-day), solar energy potential is 380 billion kWh/year. When it comes to Kırklareli, according to data of Meteorology Directorate, average daily sunshine duration of Kırklareli is 6.21 hours. Except small-capacity domestic water heating systems, there aren't any available facilities powered by solar energy.

#### BIOMASS

Turkey, which is an agricultural country, has a plentiful supply of agricultural wastes and product wastes. Around fertile agricultural lands of Turkey, Trakya region has a significant agricultural potential. Sowing of sunflower, rapeseed, soybean, canola, safflower, cotton, etc. oilseed crops are carried out in the province. In addition, energy forestry can be extended via planting qualified trees around Strandja Mountains. Animal and vegetable wastes in forests within the province can also be taken into account. Amounts and potential energy amounts of wastes mentioned are given in the tables below for Kırklareli.

## COAL

#### POPULATION

According to the United Nations' criteria, people between the ages of 0-14 are classified as children population, between the ages of 15-64 are classified as adults or working population/active population, over the age of 65 are classified as older population. 12% of the population in the province is over the age of 65, while in Turkey, this ratio is around 8%. The share of the 0-14 age group called as children population is about 25% in Turkey, while this rate is 17% in Kırklareli.





Figure 13: Population by Age Groups





## Transportation Infrastructure of Kırklareli is improving with Edirne -Kırklareli - Tekirdag - Istanbul High Speed Train Project

Developed transportation cob of Kırklareli is improving with Edirne - Kırklareli - Tekirdag - Istanbul High Speed Train Project.

The distance between İstanbul and Edirne is considered as about 1 hour with Edirne-Kırklareli-Tekirdag- Istanbul High Speed Train Project, which is forseen to be completed in 2017. With this project, Trakya almost will become a suburb of İstanbul, transportation infrastructure of Kırklareli will develop, tourism mobility will increase, economy will grow and the social life of the province will develop.



# Bulgaria's "New" economy is rising out of Kırklareli

With the Kırklareli-Burgas Railway Project ,that is considered as the eastern way of Bulgaria's economy, Kırklareli and Burgas cities will be connected by railway. Thereby trade volume, economy, tourism, social life and transportation facilities of both cities will be developed.



## Kırklareli is Becoming Stronger with Border Gates

The aim of Derekoy Border Gate Modernization Project is to modernize the border gate and provide the flow of articulated lorry traffic. A significant increase is expected in the number of people and vehicles that go throught from Kırklareli to Bulgaria with this project.

A sea Border Gate in Begendik is planned in order to revive tourism between Begendik and Rezovo.

Especially in the summer, these two points are dense in terms of tourism activity and they will more and more popular with the transition of international tourists.

Kırklareli is located in the 2nd district according to the incentive system. Investments that will be carried out in this area can take advantage of General Investment Incentive, Regional Investment Incentive, Large Scale Investment Incentive, Strategic Investment Incentive. Contributions provided to investors through incentive instruments depend on the characteristics of the investment and applicable schemes.

#### **General Investments**

Any investment subject not incentivized by the Regional, Large Scale or Strategic Schemes under the new Investment Incentive Program can benefit from supports granted by the General Investment Incentive Scheme, as long as it fulfills certain criteria. The minimum fixed investment amount should be 1.000.000 TL, the investment subject under the program should not be one of "Investment Subjects not Supported" and should meet specific criteria set for the "Conditionally Supported Investment Subjects". There are two supports for this scheme:

Value Added Tax (VAT) Exemption: Investment machinery and equipment which isimported and/or locally provided within the scope of the incentive certificate will be VAT exempt.

Customs Duty Exemption: Investment machinery and equipment imported within the scope of the incentive certificate will be exempted from customs duty set in the Import Regime Decree.

## **Regional Investments**

Investment projects can benefit from supports offered by the Regional Investment Incentive Scheme, provided that they meet the minimum investment amount and capacity requirements for industries identified for the province. Supports granted by the Regional Investment Incentive Scheme for the province are given below.

#### Strategic Investments

There is no exclusive list of strategic investment subjects. Investment projects which satisfy all criteria serving for the purposes of the scheme are regarded as strategic investments. A project that meets the following criteria can be supported within the scope of the Strategic Investment Incentive Scheme:

Minimum fixed investment shall be 50 million TL,

The domestic production capacity for the product(s) to be manufactured with the investment shall be less than the import of that product(s),

The added value brought with the investment shall be minimum 40% (excluding the refining and petrochemical investments),

The total import value of the product(s) to be manufactured with the investment shall be minimum 50 Million \$ as of the past one year (excluding the products that are not manufactured domestically).

#### Investments Benefited From Level Upgrade

The following categories of investments within the Regional and Large Scale Investment Incentives Schemes will get more benefits by getting, level upgrade in regional rates and terms of tax reduction and social security premium support (employer's share):

• Investments in Organized Industrial Zones (OIZ),

• Joint investments to be made by at least 5 companies operating in the same sector with the purpose of integrating these companies to this joint investment.

#### Specific Priority Investments

According to the Decree, there are some specific priority investment areas. If an investor interested in investing on these areas, investment will be supported by the measures that are applicable for the 5th Region even they are made in 2nd Region. This is an upgrading opportunity for the investors.



## TRAKYA DEVELOPMENT AGENCY

## Call for Proposals

Call for Proposal is an invitation for potential applicants, carrying necessary qualifications, to submit project proposals which have to comply with the pre-determined subjects and conditions. The details regarding to the call for proposal will be involved in the application guide.

The minimum and maximum amounts of support per project can differ upon the special conditions of the support program. While determining these limits, factors such as general and special objectives of the program, the qualifications of potential applicants, the appropriate project subjects and their costs, program budget and the relevant legislation are considered by the board of directors.

The co-finance rate of the projects submitted by the profit making real and legal persons and supported by the Trakya Development Agency is to be at least 50% of total relevant cost where this rate cannot be decreased in any case.

## Direct Activity Support Program

The aim of the Direct Activity Support Program is to provide financial support for strategic research, planning and feasibility studies targeted to make contribution to local/regional development, and improve the implementation capacity of regional progress and plans. The Direct Activity Support Program apparently complies with legislation and is undertaken in the frame of national plans and programs. Direct Activity Support Program supports activities that do not contain any investment component. The time duration for the projects financed under this program is maximum three months. The three month implementation phase begins just one day after contract is signed.

Municipalities, universities, other public institutions, professional organizations with public institution status, Non-Governmental Organizations, Unions and Cooperatives are only institutions/ organizations that can benefit from Direct Activity Support Program.

Under this program, Trakya Development Agency provides financial support for the activities defined in line with strategic priorities determined for regional development. Therefore, the projects that will be prepared must comply with the plans and programs in implementation.

Under the Direct Activity Support Program, minimum and maximum amounts that will be given for each project are decided upon in the limits of the legislation and determined by the Trakya Development Agency for each program. Support amounts of Direct Activity Support Program in 2014 were determined 25.000 TL and 90.000 TL as minimum and maximum amounts respectively.

## **Guided Project Support**

Guided Project Support is designed for providing financial and technical supports to projects contributing acceleration of regional development and enhancement of entrepreneurship and innovation capacity of the region. The Agency determines the project areas to be supported with its general framework and also the possible actors competent to implement it. In this type of support, cooperation among public sector, private sector and nongovernmental organizations is highly encouraged.

The implementation period of the projects under the Guided Project Support shall not exceed 2 years. The Agency may provide support at a maximum rate of 90% per project.

#### **Technical Supports**

The purpose of the technical support to be provided by the Agency is to provide technical support to the operations of local actors which have importance for the regional development however, owing to the difficulties that have been encountered during preliminary and implementation stages due to lack of institutional capacity.

KIRKLARELİ CHEESE

Kırklareli has a growing economy in terms of diary products with its local manufacturers who made transition from traditional dairy culture to modern facilities. Feta cheese types produced in Kırklareli attract attention of people who live in İstanbul and surrounding cities. Feta Cheese, Old Cheddar, Cheddar Cheese, Curd Cheese, Sheep Cheese and Goat Cheese are specific types of cheese that are produced with traditional methods in Kırklareli. Applications regarding geographical indication and trademark registration of "Kırklareli Fate Cheese" were completed; the relevant procedures are still in progress.



## NATIONAL BEVERAGE HARDALİYE

Hardaliye is a lactic acid fermented beverage produced from grapes, crushed mustard seeds, benzoic acid and it is specific to Kırklareli, Production is performed with ripe grape species such as Papazkarası, Pamit, Cardinal, Alphonse, Cabarnet, Merlot, Cinsaut, Şiraz ve Öküzgözü. When Atatürk came to Kırklareli in 1930. he tasted Hardaliye and gave directive to manufacturers in order to make Hardaliye as a national drink. Analysis and standardization of production steps of Hardaliye which has a high potential for export were completed.



## KIRKLARELİ MEATBALL

Meatball is one of the most popular tastes of the restaurants in Kırklareli, Production amount of the restaurants operating in the province is about one and a half tons in a day. It is a sought after dish for tourists coming from Bulgaria. Application was done to take the geographical indication of Kırklareli meatball but it hasn't ended up yet.
